I am applying for a precautionary disturbance licence to survey potential roosts (i.e. buildings, trees) to determine the presence of bats and to survey confirmed roosts to gather additional information on them. The licence would cover all ecologists trained in bat surveys which have previously held a licence from NPWS, as well as untrained ecologist under the condition they are accompanied by their experienced colleagues.

The inspection survey work is necessary to inform impact assessments on potential protected species present within a site and is the first step in informing further survey effort on a site, and any recommended mitigations. The staff covered under the licence will act in the interest to protect roosting bats and will not cause unnecessary disturbance on a roost: the licence is intended to cover staff in the performance of their work, in the event that a roost is found in a previously unknown location. Bats can be found during inspections at any time of the year: there are no satisfactory alternatives to carrying out inspections under a precautionary licence.
