

Derogation Number DER-OTTER-2025-03

EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS, 2011 (S.I. No 477 of 2011)

DEROGATION

Granted under Regulation 54 of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as "the Habitats Regulations".

The Minister for Housing, Local Government & Heritage, in exercise of the powers conferred on him by Regulation 54 of the Habitats Regulations hereby grants to **Philip Jordan** of **The Victorians, 15-18 Earlsfort Terrace, D02 YX28** a derogation. It is stated that this derogation is issued:

- A. In the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment
- B. As there is no satisfactory alternative, and the action authorised by this derogation will not be detrimental to the maintenance of the population of <u>otters</u> referred to below at a favourable conservation status in their natural range.

This derogation authorises the following:

- 1. disturbance
- 2. Actions authorised within the derogation in respect of otters



Terms and Conditions

- 1. This derogation is granted solely to allow the activities specified in connection with the **works** located at **offshore locations off County Dublin**, for **Philip Jordan**.
- 2. All activities authorised by this derogation, and all equipment used in connection herewith, shall be carried out, constructed and maintained (as the case may be) so as to avoid unnecessary injury or distress to any species of **Otter**. Anything done other than in accordance with the terms of this derogation may constitute an offence
- 3. This derogation may be modified or revoked, for stated reasons, at any time.
- 4. The mitigation measures outlined in the application report (P2578_R6562_Rev0_MaresConnect_Derogation Licence Supporting Report), together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
- The actions which this derogation authorise shall be completed between the 1st January-31st December 2025, inclusive.
- 6. The works will be supervised by an ecologist Aodhfin Coyle
- 7. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
- 8. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
- 9. The mitigation proposed by the applicant as detailed in Investigative Foreshore Licence for Site Investigations Ref: FS007635 Risk Assessment for Annex IV Species (excluding the mitigation proposal of using passive acoustic monitoring as a primary monitoring tool during hours of darkness) should be implemented in full.
- 10. The applicant and those acting on their behalf during surveys must ensure that they adhere to the <u>Guidance to Manage the Risk to Marine Mammals from Man-made Sound</u> <u>Sources in Irish Waters</u> published in 2014 (or any published updates as may be relevant in due course).
- 11. A qualified and experienced Marine Mammal Observer (MMO) will be appointed to monitor for marine mammals to act in accordance with the provisions of the supporting document to the Regulation 54 application.
- 12. In waters up to 200m deep, visual (MMO) observations will be conducted for a pre-rampup search of 30 minutes i.e. prior to the commencement of marine operations (MBES, SSS, sub-bottom profiling, drilling) as per DAHG guidance.
- 13. Passive acoustic monitoring may be used to supplement visual observation but it cannot be the primary method used to validate the exclusion zone.
- 14. The exclusion zone is to be monitored and validated as being clear of marine mammals as per DAHG guidance.
- 15. Ramp-up procedures will be applied as appropriate and as per DAHG guidance.

- 16. Geophysical surveys: If there is a break in sound output from survey equipment for a period greater than 10 minutes then all pre-start monitoring measures and ramp-up procedures will recommence prior to re-starting, as per DAHG guidance.
- 17. Drilling operations: If there is a break in drilling sound output for a period greater than 30 minutes then all pre-start monitoring must be undertaken in line with DAHG guidance.
- 18. Where suitable to achieve the data collection targets it is preferable to use frequencies that are higher than the acoustic range of the likely marine mammals within the acquisition area.
- 19. Works are to comply with NRA's 'Guidelines for the treatment of Otters prior to the construction of National Road Scheme.'
- 20. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
- 21. The local NPWS District Conservation Officer should be contacted prior to the commencement of any activity, and if otters are detected on site during the course of the work, under the terms of this derogation.
- 22. On completion of the activities which this derogation authorises, all recordings of otter affected will be made using the standardised data form provided below and must be submitted to the NPWS within four weeks of the expiry date of this derogation. Included with the below returns form, a report must be submitted to wildlife.reports@npws.gov.ie detailing results of works and success of mitigation. Both documents must be submitted to constitute a derogation return.
